## Juried Exhibition of New Jersey Artists

October 15 — November 5, 2010

Artists' Reception: Sunday, October 17, 1-4 PM

### ELIGIBILITY

The exhibition is open to artists living and/or working in New Jersey. Artists must be a minimum age of 18 to enter.

### ENTRY FEE

Entry fee is \$25 for current members of Arts Guild NJ or \$30 for non members, for up to 3 entries. Entry fees are non-refundable.

### SIZE & SPECIFICATIONS

The exhibition will consist of two-dimensional and three-dimensional artwork in all media. The size limitation for 2-D work is 36" x 36" framed. Wall hanging pieces must be wired for hanging. The weight limitation of wall-hanging work is 25 lbs. Plexiglass is preferable to glass.

Free-standing pieces may not exceed 40" wide or 40" deep, and 72" high, and/or weigh more than 100 lbs.

Accepted artwork cannot be substituted and must be available for the duration of the exhibit.

### SUBMISSION

Submit digital images on a CD or via our [online web form](#). Images should be no larger than 1200 pixels in either direction at 300 dpi. JPEG format only. (Images will be viewed using a PC. Please check your CD to make sure your images have been burned properly. No folders, no PowerPoint presentations please.)

Digital images must accurately represent the submitted work. Arts Guild New Jersey has the right to exclude/refuse any works which differ significantly from the selected entries or do not meet the specifications outlined above.

Arts Guild New Jersey will return CDs if a self-addressed stamped envelope with sufficient postage has been provided. Otherwise, CDs will be held as property of Arts Guild New Jersey for our files.

### ENTRY AGREEMENT

The receipt of any entry will be understood to imply agreement on the part of the entrant with all conditions set forth in this prospectus.

Brooklyn Museum

Sharon Matt Atkins is Associate Curator of Exhibitions at the Brooklyn Museum, and is the coordinating curator for the upcoming exhibition *Andy Warhol: The Last Decade* (June 18-September 12, 2010). Prior to moving to Brooklyn, she was the Assistant Curator at the Currier Museum of Art, Manchester, New Hampshire from 2004 to 2009. There she was responsible for modern and contemporary art, organizing exhibitions from the collection as well as traveling loan shows—among them *Andy Warhol: Pop Politics*, which traveled to the Neuberger Museum of Art, and *Spotlight New England: Kirsten Reynolds*. Previously she was a Research Assistant in the Department of Contemporary Art, Museum of Fine Arts, Boston, and worked at the Jane Voorhees Zimmerli Art Museum and the Metropolitan Museum of Art. A graduate of Iowa State University, Atkins received an M.A. and Ph.D. from

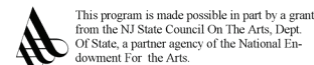
